#### **CSA partners with BROMMA for Technical Forum**



Port operators know that investments made in procuring the finest equipment complemented be comprehensive training of personnel who operate and maintain these valuable Caribbean Shipping assets. The Association (CSA) has always placed a high priority on its mandate for training and therefore partnered with BROMMA in staging a joint Technical Forum, which was be held virtually on Wednesday, February 24, 2021.

During this forum, BROMMA representatives delivered presentations


on training, repairs, safety, and updates that can help teams throughout the Caribbean and Latin American Region to increase productivity and safety at their terminal.

In welcoming the more than 80 participants to the region-wide training forum, Marc Sampson, Vice President of the Caribbean Shipping Association, described the event as "another great example of how the Caribbean shipping industry is proving our resilience and our commitment to continuous growth, development and innovation."

The CSA VP noted that the past year has opened the eyes of the world and the region to the critical role of shipping in the lives of every citizen of earth. He said: "The maritime sector is now being seen for what it is, the stable center of the world economy. It is because of our commitment to modernization and our willingness to embrace new technologies that we have managed to keep the supply chain open and functional in the worst of times."

Sampson told forum participants that the CSA's emphasis on training, throughout its history, has been vindicated and, he was taking the opportunity to remind CSA members and supporter of need for more sponsorship for the CSA Training Fund (now the Frank Wellnitz Training and Wellness Initiative).

"Training benefits all of us, so let us contribute generously in creating a rising tide which will lift all ships," the CSA VP exhorted. He encouraged all in shipping to contact the CSA Secretariat to make arrangements for donations to the Frank Wellnitz Training and Wellness Initiative.



Milaika Capella Ras, General Manager of the CSA introduced forum participants to the presenters from BROMMA, who were: Federico Botero- Director of Sales and Services; Peter J. Brill – Product Support Manager – AMER; Neftaly Rodriguez – Field Service Coordinator, and Danny Adames – Field Service Engineer

The team's presentation included: technical support for structural damages and repairs procedures; the MRX100 MHC Rotator; types and usage of MHC Safety Platforms; the SCS Modular with Spreader Information Display (SID), and a discussion of challenges and solutions at terminal sites.

Much interest was shown for the Onsite and Virtual Spreader Training offered by BROMMA which is offered at four (4) levels, from 2 days to 6 days. A sample of the Training Agenda for one 6-hour day of training was shown and discussed, and it was noted that the agenda can be modified to emphasize a particular topic as required.

Mrs. Capella Rasl in her closing remarks, thanked the BROMMA Representatives for their informative presentations and provided participants with details on the next CSA Webinar entitled Where is My Cargo? That webinar focuses on Maritime Supply Chain Cybersecurity in partnership with HudsonAnalytix. Focusing on the maritime supply chain and cargo management.

### HIT Rio Haina Port donates to Dominican Customs a X-Ray machine for container inspection

This high-tech scanner will make inspection and cargo dispatch operations more agile, efficient, and safe at Río Haina Port.

With the aim of facilitating the inspection of goods and reducing the time of stay of the containers in the Rio Haina Port, HIT donates to the Dominican Customs (DGA) a latest generation X-ray scanner, RAPISCAN Eagle P60-S.

"With the donation of these scanners, HIT continues to bet on the facilitation of our nation's international trade by guaranteeing that the processes of entry and dispatch of merchandise through the Rio Haina Port are carried out efficiently, safely and in accordance with the Law", stated Erik Alma, CEO of HIT.

The director of the DGA, Eduardo Sanz Lovatón, explained during the signing of the intention agreement, that the installation of this valuable tool is in line with the efforts made by the current management to make the institution's operations more efficient, modern and safe. In addition, this initiative supports the Government's objective of enabling the dispatch of containers in 24 hours.

Sanz Lovatón thanked HIT Rio Haina Port while showing appreciation for the donation of the X-ray equipment, since this scanner "will contribute to the modernization and technological innovation actions that we have been deploying with the purpose of generating a true transformation in the DGA, heading towards the new Customs that the country wants and needs ", he said. In addition, the director of the DGA assured that the installation of a scanner for cargo verification in Rio Haina Port is another step forward towards the route that seeks to position the Dominican Republic as a world-class logistics hub and, with it, guarantee a safe and agile international trade.

Its aim is to become the main and the most important multipurpose terminal in the Dominican Republic; 60% of the international maritime trade that is exported and imported in the country passes through this port terminal. Since its beginning as the operating company that develops the Rio Haina Port, HIT has invested more than 140 million dollars in specific areas such as infrastructure, technology, and security, making this port a world-class multipurpose terminal.

"With this donation, at no cost to the Dominican State, we will be in a better position to perform the double role that the DGA is called to fulfill, guaranteeing national security and facilitating foreign trade by increasing our logistics efficiency through the implementation of technology. "Said the Director of Customs.

Mr. Alma highlighted: "This donation strengthens the main objective of public-private partnerships, which is to return benefits to the country.

#### **Cutting edge technology**

HIT is investing around 3 million dollars in the purchase, infrastructure and installation of a RAPISCAN scanner, model Eagle P60-S, manufactured in the United States; an advanced technology equipment that will speed up inspections of containerized cargo, since the trucks will not need to stop their march for the system to carry out the scanning process. With this state-of-the-art equipment, up to 100 containers per hour can be inspected.

The Eagle P60-S scanner allows the truck and container to be thoroughly inspected, regardless of the density of the load or its condition, thus ensuring a safe, efficient and fast recognition by providing a detailed view of the merchandise inside of the container.

### **CSA and HudsonCyber Complete the First of Three Cybersecurity Exercises**

Over the last few years, cyber attacks have continued their inexorable rise up the rankings of risks that keep executives awake at night. In the maritime industry, cyber attacks have successfully breached organizations as large as Maersk, CMA CGM, MSC, the Port of Long Beach, and even the International Maritime Organization. The damages of cyber attacks can be severe. Just this March a multinational shipping company suffered a malware attack that left 65% of its global office-based staff without access to their company computers for almost a week. Luckily enough, as soon as they realized a breach had occurred, they contained the breach by shutting off all connections to their vessels, and as such, no vessel was affected.

In view of this emerging risk, on April 8 the Caribbean Shipping Association (CSA), in collaboration with HudsonCyber, hosted the first of three virtual cybersecurity exercises scheduled for 2021. This first one focused on the maritime supply chain. Titled Where is My Cargo? A Maritime Supply Chain Cybersecurity Exercise, the exercise brought together 30 participants from all of CSA's membership groups, offering them the opportunity to practice managing cyber risk in collaboration with other organizations in their supply chain community.

"We know how important cybersecurity and cyber risk is to our members, so the CSA is taking a leading role in cybersecurity and cyber risk awareness training and education throughout the region," said CSA General Manager Milaika Capella Ras. "We were excited to partner with HudsonCyber to host this first-of-its-kind exercise in the Caribbean, and we were thrilled to have so many participants from across so many of our members."

Participants received an initial briefing on maritime supply chain cybersecurity and cyber risk management from HudsonCyber's Senior Manager Chronis Kapalidis, who presented maritime cyber context, discussed relevant supply chain risk case studies, and reviewed steps to take to reduce cyber risk in the maritime supply chain.

"General awareness training is, in some cases, not sufficient anymore," said Mr. Kapalidis. "That is why, in cooperation with CSA, we designed these unique supply chain, hands-on exercises. In an interconnected world, we should certainly be

able to identify, protect against, and respond to cyber incident, but we must also understand how this incident may affect the entire supply chain".

After the briefing, participants were divided into groups and given sample organization profiles to review and represent. Each group then examined and discussed exercise scenarios and addressed the challenges and questions that arose from the perspective of those organizational profiles. Participants deliberated on how best to defend their organizations and presented findings to the group. Finally, during the exercise's most spirited session, participants described how they might attack those organizations if they were cyber attackers.

"The exercise was a great way to focus on cybersecurity in the maritime sector and hear ideas from everyone in the group," said Rommel Edwards, Director of Innovation at Barbados Port, Inc. "Everyone comes from a different background and works for a different organization, and we all learned from hearing each other's perspectives."

This exercise was the first of three cybersecurity-oriented exercises the CSA and HudsonCyber will organize this year. On September 9, they will hold the second virtual exercise with a focus on cyber incident response and recovery. At the CSA's annual general meeting in Puerto Rico in November, they will host the third session, which will be a hybrid in-person and virtual exercise focused on executive-level organizational cyber risk management.
